APPLICATION FOR Ministerial Credentials

Our credentials enable you to be recognized as a God called *pastor, evangelist, youth pastor, children's pastor, missionary, counselor, chaplain, minister of music, worship leader, or teacher.* All applications are carefully considered, and applicants receive a copy of the ICCAN CONSTITUTION AND BY-LAWS for review prior to their telephone interview.

Credential Qualifications

- 1. Must have made a personal commitment to Jesus Christ as Lord.**
- 2. Be in agreement with the ICCAN Statement of Faith.**
- 3. Have appropriate ministerial and educational background, as well as a proven ministry.**
(Note: A degree is not required to acquire credentials see #20 page 3)
- 4. Promote and support ICCAN with your prayers, giving and attendance at conventions and events when able to attend.**
- 5. Demonstrate the fruit of the Spirit in one's life and a desire to grow in the wisdom and knowledge of the Lord Jesus Christ.**
- 6. Provide three character references which affirm and endorse a life of integrity and a proven ministry. One of these must be from a pastor or minister.**
- 7. Be interviewed by the ICCAN Credential Committee, which will then recommend to the Board of Directors approval for License or Ordination.**
- 8. Support ICCAN by giving a one-time application fee, annual renewal fee and monthly love offerings. (see page #4)**

NOTE: Due to legal and insurance constraints, ICCAN is unable to accept applications for membership from incarcerated applicants (prison inmates)

CREDENTIAL RENEWAL:

Credentials are renewed annually on October 1st of each year. Ministers receiving credentials within a particular year, there renewal will be the following year on October 1st. There is a \$50.00 renewal fee for Licensed and \$75.00 for Ordained Minister.

FINANCIAL OBLIGATION: *To provide a solid base of support and maintain the ability to operate as a solvent fellowship/ministry, thus enabling ICCAN to reach out to the body of Christ around the world with the tools needed for effective ministry, Licensed Ministers are required to financially support the ICCAN Fellowship with a monthly love offering of \$20.00 minimum and Ordained Ministers \$25.00 per month minimum.*
